#### About the Department

The Office of Real Property Tax Service maintains and continually updates the Real Property Data Base on a daily basis with the most current information available for each property in Franklin County. Based on this information the tax maps are kept updated which can be linked up to each parcel in the Real Property Data Base. This data base is the basis for all property tax bills within the County, including all municipalities, school districts and special districts and is vital intellectual property. Also the tax maps are a very useful tool for the Assessors and the public. "The law provides that a tax map is prepared for the use of Assessors, therefore, a tax map is to be used primarily for Real Property Assessment and Taxation Administration." It is intended to be used only to describe the parcel for the purpose of Assessment Levy and Enforcement of Taxes (Opinion of Council: Book 5 Page 93). The department works in conjunction with municipal assessors and government agencies to ensure assessment rolls are

equitable and are properly maintained, and provides other support services to municipal assessors as needed. The department also maintains their own portion of the County Web Site (franklincountyny.gov under the Real Property Tax Services Department) with such information as the posting all the Assessment and Tax Rolls and various other helpful information along with a web-based GIS mapping application, wherein the County tax maps are available on-line.

#### School Tax Relief (STAR) Credit Program-New 2016 (see link below)

Congratulations on your new home, you may be eligible for STAR Credit.

If you own your home, it is your primary residence, and your income is \$500,000 or less, you're eligible for the Basic STAR credit.

If you are 65 or older with an income of \$98,700 or less, you may be eligible for the Enhanced STAR credit.

There are two ways to register for the above credits: You can register 24 hours day, 7 days a week

https://www.tax.ny.gov/pit/property/star or by calling (518) 457-2036 weekdays from 8:30am to 4:30pm.

Eligible new homeowners will receive their STAR savings in the form of a check directly from New York State.

# ENHANCED STAR EXEMPTIONS (MUST HAVE BASIC STAR EXEMPTION ON PRIMARY RESIDENCE CURRENTLY, IF NOT SEE ABOVE):

Property owners 65 years of age or older, who presently have a Basic Star Exemption on their primary residence, but would like to apply for an Enhanced STAR exemption, must complete the RP-425-E and supplement forms (

please see documents, click on drop down arrow and look for RP-425-E) and return to their local assessor (list of Assessors is listed under Documents) prior to March 1st.

<u>PLEASE NOTE:</u> Please check with your local assessor for any other senior citizen exemptions you may be eligible for prior to **March 1st.**
